2. New Business:

1. HRAC Comments on Downtown Douglas/ West Juneau Area Plan- Chair Lorenz prepared comments on the plan and was told by staff that she commented beyond the section in which staff was asking for comments on. Chair Lorenz indicated she didn't think the comments would be taken into consideration since the plan has already been in front of the Planning Commission and changes are difficult. Mr. Winker pointed out the last survey conducted on Downtown Douglas was in 1989 and it needed to be updated. Chair Lorenz doesn't think we did a good job at documenting the history and voices of what happened where.

Chair Lorenz asked for unanimous consent on passing on the comments to CBJ. It passed.

2. Star Hill – Recorder Crossley requested information on Star Hill being available online. The Mineworkers Houses report was the only document found on CBJ's portal, she was hoping there was a historic survey of the neighborhood. Staff was able to find an Inventory of Historic Sites and Structures report from 1986 with some of the buildings surveyed. This was the information Mrs. Crossley was looking for.
