1. **USE2026 0003: A proposal for a conditional-use permit to provide for the stabling of farm animals for personal use in a D-3 zone. — Continuation from the August 11, 2026 Regular**

Planning Commission Meeting

Applicant: Southeast Endeavors, LLC

Location: 10226 Silver St; 10228 Silver St

DIRECTOR'S REPORT

The applicant requests a conditional-use permit to provide for the stabling of farm animals for personal use in a D-3 zone. The applicant noted that they would like to have up to 200 hens, roosters, and meat chickens at a time, and up to 30 other farm animals at a time, which under the current iteration of Code, means horses, cows, sheep, goats, swine, ducks, chickens and other similar animals, but not including domesticated cats and dogs. The lot is large, in a new subdivision, and the applicant owns the lot directly to the north, which if stayed under their ownership, could allow for a buffer of around 200 feet between the hobby farm and the next nearest neighbor's house. Title 49 is limited with regard to specific regulations that pertain to the proposed use.

STAFF RECOMMENDATION

Staff recommends the Planning Commission adopt the Director's Analysis and Findings and Approve Conditional Use Permit USE2026 0003 with the requested conditions.
