F. STAFF REPORTS

Elected Official Report-Wade Bryson – reported that the Hospital Board was approved at the Monday June 12 Assembly meeting.

Emergency Programs Report – Tom Mattice reported that the State moved the award of Federal grant funding to proceed with Whole Community all hazard planning revisions to the Fall and will begin community planning meetings at that time. CBJ Emergency Programs will be hiring an individual in November to train into the coordination position Michelle is retiring from at the end of February.

JPD-Scott Erickson & Krag Campbell reported on the city's new armored emergency preparedness and response vehicle, which was successfully used recently for an incident. It is based on the frame of an F550 with added ballistic armor which allows on the scene officers safety in unsafe environments. The vehicle will be shared between multiple agencies and will allow response to multiple missions including going through high water in case of flooding that normal vehicles cannot travel through. If approved, it will be used for National Night Out. No current plans to change the paint from bright red; multiple city agencies collaborated and agreed upon the color. The vehicle is currently being dubbed "Clifford" in honor of the

children's tale "Clifford the Big Red Dog". Thank you to Tom and Michelle for the years of work they put in in helping secure this vehicle.

CCFR – Ed Quinto reported they have been working on training their staff. They are currently hiring, please refer anyone who might be interested to them. There will be official job announcements going out in August.

Hospital – Evan Price reported they experiences a technical problem on June 29th but were able to restore full network capabilities shortly. There was no impact on patient care due to the problem.

Haz/Mat – Nicole Ferrin advised that Suicide Basin is still being monitored. Images on the website are updated around 8am and 2pm daily. At current rate of rise, the basin should over cap in around two weeks. They supported the voyage of the Polynesian voyaging canoe throughout Southeast waters until they were handed off to British Columbia, Canada. Fire danger has not been elevated yet this year due to a wet spring.

Alaska Native Tribal – Sabrina Boone reported T&H recently had 25 employees complete the train-the-trainer ALICE course. The goal is to start expanding the education of employees and then possibly open the training up to the general public. Currently looking at adding an additional village SEARHC option, this will be officially announced after they finish the official paperwork.
