V. Unfinished Business

- **Douglas Island Cemeteries.** It was noted that letters to the editor are not permitted from advisory boards, according to CBJ code.
- **“Welcome to Douglas Island” Sign at the Roundabout.** MK reported in an email that she had contacted Douglas Indian Association (DIA) with no response, and so advises that DAB to move on to a new plan. Jo volunteered to start researching new funding and design options. She will contact Di at CBJ clerk’s office about fundraising protocols for CBJ boards, and report at the next meeting.
- **Rest Rooms at Savikko Park.** The Boy Scouts noted that the rest rooms were closed and locked for their event which was frustrating and an inconvenience, and they are open to getting involved in addressing it, including writing a letter to CBJ Assembly. Jo will work with MK to research groups that may be affected, with possible contact with those entities to request letters to the Assembly. Kayla will contact the theater groups that use the area.
